



## 2023 Scholarship Application Terms and Conditions

By applying for a scholarship awarded by Zone 7 Beyond Health Inc. ("Zone 7"), you agree to these terms:

- You may not apply for more than one scholarship, and you only need to complete one application to do so. Submitting additional applications will not increase your chances of being selected.
- You must provide your email so that we can contact you if you are selected as a scholarship recipient. If you are selected, you must provide your mailing address so that we can send your award.
- To be awarded a scholarship, a recipient must enroll at an accredited college or university located in the United States. Scholarship proceeds will be awarded directly to the applicant following selection. Upon selection, the recipient will receive forms via email and will need to complete all forms within 14 days. If these forms are not completed within 14 days, the award will not be disbursed and the recipient may forfeit the award.
- By applying for a scholarship, the applicant grants Zone 7 permission to use their name on the Zone 7 website or in other social media communications should they be awarded the scholarship.
- Scholarship recipients will be required to submit a current photo(s) and submit a publicity release granting Zone 7 permission to use their photo on the Zone 7 website and in other social media communications.
- Zone 7 reserves the right to change scholarship awards at any time, including available scholarships, deadlines, requirements, award amounts or other scholarship details.
- Personal information collected by Zone 7 in the scholarship application process will not be sold, shared, or otherwise redistributed. - Applicants will be assessed subjectively by Zone 7 based on need, community impact, vision, and academic aspirations. Zone 7 does not and shall not discriminate on the basis of race, color, religion (creed), gender, gender expression, age, national origin (ancestry), disability, marital status, sexual orientation, or military status, in any of its activities or operations, including the awarding of scholarships.
- Scholarship winners will be contacted by email within six weeks of the posted scholarship application deadline.
- If winners do not reply by the date specified in the email, Zone 7 reserves the right not to award the scholarship to the winner, and to award the scholarship to another applicant or to redistribute the scholarship award dollars to another scholarship.
- The Zone 7 Scholarship and Valley of the Sun Scholarship (referred to collectively as the “scholarships”) are open only to residents of California and Arizona with connections to the San Francisco Bay and greater Phoenix metropolitan areas, thirteen (13) years of age or older whose application for these scholarships does not violate any applicable law or regulation, including the Children’s Online Privacy Protection Act, and currently planning to enroll in an accredited post-secondary institution of higher learning (college, university or trade school) located in the United States within two years of the scholarships’ awarding. If you are a parent or legal guardian of an entrant under the age of 18, by allowing your child to apply for these scholarships, you are subject to these Rules. Entrants under the age of majority in their state of residence (“Minors”) must have permission to enter from their parent or legal guardian and will be required to obtain a written release from their parent or legal guardian prior to claiming any scholarship reward. Proof of permission may be required at any time. Online entries will be deemed submitted by the authorized owner of the email address and other contact information submitted at time of entry. These scholarships are subject to all applicable federal, state, and local laws and regulations.
